变更原因/Reason for Change:

为进一步响应中国无线电管理局的标准要求,乐鑫信息科技(上海)有限公司正式通知国内外模组产品客户,针对在中国大陆境内发售使用的模组,公开接受客人定制。

In response to the standard requirements of the State Radio Regulation of China, Espressif Systems (Shanghai) Pte., Ltd. hereby notifies domestic and international customers of our module products that we accept orders of modules customized for sales and use in mainland China.

变更描述/Description of Change:

- 1. 全系列所有模组产品,将区分两类标签: 国内版,国际版 (见下方示例)。 One of two different labels, for module sales and use in mainland China and overseas, can be provided for all Espressif module products, i.e. the China label and the international label (See examples below).
- 2. 默认国际版 (镭雕标签带 FCC CE 等) 为乐鑫通用模组。By default, all Espressif modules come with the international label (with markings including FCC and CE…).
- 3. 国内版本(镭雕标签带厂牌,型号,CMIIT ID 等)需要**客人定制**,仅适用于产品在中国大陆境内使用的产品,或者终端产品。国内版本的标签将严格与产品提交 SRRC 认证的标签资料一致。Modules with the China Label are **only provided upon customers' requests**. And the markings on the China Label (with the information of the manufacturer, product model, CMIIT ID...) will be exactly the same as those in the label information submitted to the State Radio Regulation of China for acquiring the SRRC certification. Note that any modules with the China label or any end-products that use these modules must only be sold and used in mainland China.
